New Delhi: The government is likely to form a council on the lines of GST council with states to roll out the National Health Protection Scheme, announced in the Budget on Thursday.

The plan also includes creation of a mission for focused implementation of the scheme.

"The plan is to form a committee on the lines of the GST council to implement the Modicare scheme because a few states have such a plan and a way needs to be found together to get this scheme with states, where a similar scheme is already being offered," said a senior government source.

Another government source said a mission kind of arrangement would also be made to implement the scheme.

In the current fiscal year, these companies had targeted an expenditure of ₹87,400 crore, 50% of which will go to exploration and production.
