Respected Sir,

- I, Sanjay S. Risbud, Practicing Company Secretary (Membership No. 13774 and C. P. No. 5117) have been appointed as a Scrutinizer to conduct the postal ballot process in respect of below mentioned Ordinary Resolutions pursuant to the Notice dated October 29, 2021, issued under Section 110 and other applicable provisions of the Companies Act, 2013 ("the Act") read with the Companies (Management and Administration) Rules, 2014, as amended from time to time read with the General Circular No. 14/2020 dated April 08, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020 and General Circular No. 10/2021 dated June 23, 2021, issued by the Ministry of Corporate Affairs (hereinafter collectively referred to as "MCA Circulars"):
 - ENHANCEMENT OF THRESHOLD LIMITS OF CERTAIN RELATED PARTY CONTRACTS FROM RS. 50 CRORE TO RS. 100 CRORE PER ANNUAM PER TRANSACTION.
 - APPROVAL FOR RELATED PARTY CONTRACT WITH VIBRANT FOODS NEW JERSEY LLC, STEP DOWN SUBSIDIARY OF THE COMPANY WITH A THRESHOLD LIMIT OF RS. 100 CRORE PER ANNUM.
 - 3. APPROVAL FOR CORPORATE GUARANTEE TO BE ISSUED ON BEHALF OF ADF HOLDINGS (USA) LIMITED NOT EXCEEDING USD 8 MILLION.
- 2. On account of threat posed by COVID-19 and in terms of the aforesaid MCA Circulars, the Company had send Postal Ballot Notice in electronic form only and hard copies of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope were not sent to the Members for this Postal Ballot.
