**Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Acquisition of additional shares in the Wholly Owned Subsidiary of the Company, Telluric Foods (India) Limited.**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that the Board of Directors of the Company, in the Board Meeting held today i.e. on Wednesday, 14<sup>th</sup> May, 2025, *inter alia* considered and approved acquisition of additional shares in Telluric Foods (India) Limited (“TFIL”), Wholly Owned Subsidiary of the Company by way of further investment of up to Rs. 9,00,00,000/- (Rupees Nine Crores Only), in one or more tranches, in Optionally Convertible Redeemable Preference Shares (“OCRPS”) of TFIL.

Further, the aforesaid investment will down-stream to Telluric Foods Limited, a stepdown Wholly Owned Subsidiary of the Company, by TFIL and the same will be used to support the brand building and working capital requirement of the said subsidiary for FY 2025-26.
